Contemporaneous penalties are based on a team's multiyear NCAA Division I academic progress rate (APR) (i.e., 2003-04 and 2004-05) and on an individual student-athlete's eligibility/graduation and retention status for the 2004-05 academic year.

Athletics teams with a multiyear APR below 925, including application of the appropriate squad-size adjustment, may be subject to contemporaneous penalties. The following athletics teams at this institution have an APR below 925 and are subject to the noted penalty. The teams' APRs are noted, as well as the value of the total financial aid penalty to which the team is subject.

The noted penalties must be taken as soon as possible without impacting incoming student-athletes. In practical terms, the penalties must be taken in 2005-06 or 2006-07.
